# PERMIT GUIDELINES & FEE SCHEDULE

#### 1. Yard Sales

- Village Clerk Approval
- No Fee
- No paperwork required applicant calls the village office indicating name, address, date and time of sale. Three yard sales are allowed per calendar year for up to a four day period.

#### 2. Banner Permits

- Village Clerk approval
- \$25.00 Application Fee
- \$75.00 Installation Fee
- Must follow "Guidelines for Main Street Banners"

## 3. Display of Merchandise on Private Property

- Village Clerk Approval
- \$25.00 Application Fee for one-year period
- Must complete application and adhere to permit requirements

#### 4. Parking of Vehicles on Private Property

- Board of Trustees sets dates (Special Event Weekends)
- Village Clerk & Police Chief Approval
- \$25.00 Application Fee
- Must complete application and permit requirements

#### 5. Profit Vendor on Private Property (Business District)

- Board of Trustees sets dates (Special Event Weekends)
- Village Clerk Approval
- \$25.00 Application Fee
- Must complete application and permit requirements

### 6. Profit Vendor on Public Property

- Board of Trustees sets dates
- Board of Trustees Approval
- \$10.00 Application Fee per Participant
- \$250.00 per event
- See special instructions

#### 7. Non-Profit Vendor on Public Property

- Board of Trustees sets dates (Special Events Weekend)
- Village Clerk & Police Chief Approval
- \$10.00 application fee

#### 8. Non-Profit Vendor on Private Property

- Board of Trustees sets dates (Special Events Weekend)
- Village Clerk & Police Chief Approval
- \$25.00 fee per event

## 9. Blanket Permit by Non-Profit for use of Public Property

- Board of Trustees Approval
- \$15.00 fee per Exhibitor or \$500 minimum
- See special instructions

### 10. Village Use Permits

• A Certificate of Insurance naming the Village of Cooperstown as additionally insured with coverage of \$2,000,000 aggregate, \$1,000,000 occurrence.
